# CITY OF COQUITLAM

#### **Public Delegations**

- You may request to appear as a delegation, meaning to present to council, before a standing committee of council to bring awareness to an issue, project, or idea or to discuss an item currently under consideration. See the Delegations Policy & Process section on the How to Get Involved webpage.
- To appear before council-in-committee, an individual or organization must submit a Delegation Request Form to the City Clerk's Office at least **7 days** before the meeting they wish to speak at.
- The committee will hear a maximum of 3 delegations per meeting. Speakers have **5 minutes** to present.
- The City Clerk's Office selects delegations in the order they are received.



#### **Speaking on a Member Motion**

- Member motions are infrequent.
- There is a public question period following the adjournment of regular council meetings where members of the public can ask questions to council.



### Community Advisory Committees

- There are committees and boards with different combinations of council members and citizen representatives. Visit the Committees & Boards webpage for information.
- List of committees and boards: Board of Variance; Community Safety Advisory Committee; Coquitlam Public Library Board; Coquitlam Youth Council; Culture Services Advisory Committee; Economic Development Advisory Committee; Finance Standing Committee; Multiculturalism Advisory Committee; Sports and Recreation Advisory Committee; Strategic Priorities Standing Committee; Sustainability & Environmental Advisory Committee; Universal Access-Ability Advisory Committee.
- Most committees have a 1-year term with an opportunity for outgoing members to apply for renewal during the annual recruitment process.
- You can watch advisory committee meetings Advisory committee meetings in person or electronically.
- The committees list includes the Coquitlam Youth Council (CYC) for Coquitlam residents in Grade 10-12.



- If you believe you will be affected by a proposed zoning bylaw, you may present your views to council. Visit the Public Hearings webpage for information.
- You may submit written comments ahead of the meeting or present in person or via Zoom.

- Submit Written Input: Email or write to council.
- Submit a Petition: Submit a request to support or oppose a matter under debate.
- <u>Present to Council</u>: If you want to make a presentation to council on a non-business item, you can request to present at a council meeting by contacting the Clerk's Office.
- <u>Direct Email Services</u>: Subscribe to receive updates from different advisory committees and on city projects.
- <u>Financial Plan Involvement</u>: Coquitlam conducts an online public survey during the annual budget planning process.
